1.1 ABOUT SeSTA:

Seven Sisters Development Assistance known as SeSTA (www.sesta.org) is an NGO registered in the year 2011, that works directly with poor and marginalized communities in 24 districts of Assam, Meghalaya, and Tripura. We are presently working with over 1.5 Lakh families directly to reduce poverty through enhancing assets/capabilities and facilitating access to sustainable income-earning opportunities. To achieve this vision, we have placed 160 highly motivated and skilled professionals in villages who work directly with communities to:

• Promote/nurture women's collectives to build capabilities and leverage institutional finances for members' livelihoods

- Develop and introduce locally suitable Livelihood activities to increase incomes
- Mobilize finances for livelihood assets and infrastructure
- Set up mechanisms to sustain the livelihood gains made by the communities

1.2 What is the opportunity?

For a project titled 'Women Farmers Cluster Development Project in Assam" which aims to uplift 4000 women farmers by establishing targeted clusters focused on vermicompost production, vegetable cultivation, horticulture, spices and honeybee farming over a period of 3 years. Recognizing the vulnerability of traditional crops to climate vagaries and market fluctuations, this initiative promotes diversification for resilience and economic stability.

SeSTA is looking for a competent Organization/Firm/Individual Consultant(s) to conduct a baseline study in the proposed working areas with structured tools & methodologies as well as detailed analysis which will allow us to generate various understanding for planned execution of the project. The key attributes of the study should include:

• Sampling & Methodology

We want a strategic sampling method around 4000 women farmers. The study must include processes based on the sample method uptaken from the range of total women farmers.

• Technology Incorporation

We would also want the details of what tools the organization/firm/individual consultant(s) is using or will be using for this data collection process.

1.4 SCOPE OF THE STUDY:

- Demographic details
- Educational background and literacy rates among women farmers.

• Existing sources of income and livelihoods, type of agricultural activities currently practiced by women farmers, productivity levels, traditional agricultural practices, existing knowledge and skills.

- Current income source wise
- Current expenditure pattern
- Market analysis for products, market participation and sales, legal barriers or constraints faced by women farmers.

• Current status empowerment, such as women's decision-making power, gender equality related to agriculture and access to and control over productive resources, financial independence, mobility, participation in different forum

- Access and usage to resources such as land, water, farm mechanization and technology for women farmers.
- Access to rights and entitlements
- Status and health of community institutions viz. SHGs, VOs, PGs and CLFs
- Understand the role of stakeholders in the farming community.
- Recognize the stakeholders' role in value chain development and project sustainability.
- Comprehend the challenges and gaps in the existing market system.
- Identify issues in the production process.
- Address skill gaps in the community.
