SUPPLY OF VETERINARY KIT FOR PASHU SAKHI

The Procurement Committee hereby declares the technical and financial evaluation results based on the tender evaluation process as follows:

Sl	Bidder Name	Technical Score	Financial Score
1	Maa Kamakhya Drug Surgical	27	37.28
2	Ecomborbit Solution LLP	40	45.60
3	Jaikissan Seed Corporation	Disqualified	
4	Bonsai Enterprise	Disqualified	

After the opening of the bids, it was observed that Bonsai Enterprise had submitted the lowest bid amount but failed to submit the required documents. Consequently, the Procurement Committee decided to disqualify both Bonsai Enterprise and Jaikissan Seed Corporation for non-compliance with the bidding requirements.

Among the remaining bidders, Ecomborbit Solution LLP and Maa Kamakhya Drug Surgical submitted all the required documents and were found to be technically responsive. After evaluating their financial bids, the Procurement Committee selected Ecomborbit Solution LLP, as it had submitted the lowest responsive bid.

Followingh Formulation was used to determine the combined final evaluation score of both the technical and financial proposal Proposal will finally be ranked according to their combined technical(Tb) and financial(Cb) Scores as follows $Bb=(0.6*Tb+(0.4)*(Cmin/Cb)*100$, Where
Bb=Overall Combined score of bidder under consideration (calculated up to two decimal points)
Tb=Technical score of the bidder under consideration
Cb=Financial bid value of the bidder under consideration
Cmin=Lowest financial bid value among the financial proposal under consideration Based on above formula score as follows
